purpose of TWIN

To honor women who have excelled in their fields and made significant contributions to their corporations in an executive, managerial and/or professional role and to salute corporations for establishing policies and practices that provide opportunities for women.

TWIN criteria

- A company can participate on one of six levels:
 - The Host Company and Leader companies may nominate up to three honorees.
 - Benefactor, Charter Sponsor and Sponsor companies may nominate up to two honorees.
 - Patron companies may nominate one honoree.
 - A subsidiary is a separate company with its own level of sponsorship.
- Each nominee must be employed by the sponsoring company for a minimum of two years.
 - Each nominee must have made a significant contribution on a managerial, executive or professional level.
 - Each nominee must be employed by the sponsoring company on the night of the awards dinner.

TWIN honoree nomination

The TWIN awards are not competitive. Each nomination is evaluated on its own merit. Nominations are reviewed by a committee of corporate personnel officers, YWCA of Bergen County Board members and previous TWIN honorees. The committee seeks honorees who have demonstrated leadership and exceptional talent and have obtained a significant level of achievement within a career path.
